GET READY – IT'S THE JULY 4TH EVENT!

Summer is here and everyone is getting anxious for Crest's 64th July 4th event!

Are you ready to participate in this year's parade? We hope to see many of you with your decorated floats competing

for some great trophies. This is a family event and everyone can participate.

Note, there is a new start time this year. The parade will be starting at 9:00 am rather than 9:30 to help coordinate times with the local churches.

As far as the parade line-up is concerned, there will be cones and signs as to where you or your group needs to line up in South Lane Park. You do not need to pre-register. Horses and other animals need to be in the large arena for safety as we organize and place the various groups in order. Both the San Miguel Fire Department and units from Cal-Fire will be there to assist in the judging and organizing the parade participants. If you plan on participating in our parade, be down at South Lane Park at 8:00 for lineup and judging. The parade will step off at 9:00 a.m.

Remember the streets will be blocked as the parade passes between 9:00 and 10:30. The parade marches from South Lane Park, up Albatross to Suncrest, and La Cresta Blvd ending just past Nancy Jane Park. Thanks, again, to the San Miguel Station 18 and Cal-Fire for supporting our parade and providing first aid services this year.

Following the parade, festivities will follow in at Nancy Jane Park. We have moved the food back into the park this year now that we have a better understanding of the permit process and regulations. Look for some great food this year provided by the CCA, Kiwanis, St Louise Church and the Crest Fire Safe Council. Bring your appetite and look for hamburgers, hotdogs, tamales, snow cones, nachos and ice cream. Remember, proceeds from this event are the primary fund raiser that pays the CCA bills.

Once again there is music lined up on the 4th playing from 10:00 – 1:00. We will have vendors selling their wares. Seller's permits are required, so if you are all set in this area and want to participate as a vendor, contact Kandhy Franklin at 444-4996 or kandyfranklin@cox.net. (You can get a permit in one day by going down to the office on Front Street in person and applying.)

Plan to visit the CCA Clubhouse and peruse the Historical Society's interesting albums. This will also be the location of our Silent Auction. PARADE ROAD CLOSURES- JULY 4

The main road, La Cresta, will be closed in the morning to through traffic for approximately 45 minutes until last parade participant passes. The road may be closed from 8:30-10:30 at certain locations. Alternate routes will be posted if you are going into South Crest. Of course, if there is an emergency, the volunteers will radio the command center.

MORE PARADE INFORMATION

All parade participants need to show up for Judging at 8am. We will have signs at South Lane Park which will give the order of the parade. This is the order: First the fire engines. Next, CREST HISTORY ON PARADE, our Parade Grand Marshals: Dan Wilson, Dorothy Miller, and Virginia Fortham. Next, are Politicians, the floats, and then the motorcycle club of Crest with all our junior motorcycle riders. Please note that all motorcycles need to stay in a group due to safety issues! Please do not pass the fire engines! Next are the tractors, cars, and antiques. Following that are the golf carts, Rhinos, floats, groups and organizations, and finally the animals. We could use your help to keep everyone organized. If you have an animal, please keep your animals in the large arena or on the backside of the park. Jeff Stenmo and Kandhy Franklin will help with the line up.

VOLUNTEERS NEEDED!

We need volunteers at each intersection to place and remove the barricades. As the parade finishes, the barricades will be picked up. If you are planning on being a spectator and are willing to help, call 44-CREST and leave your name and phone number, A short meeting will be held Saturday morning, July 3 at 9:00 at the Clubhouse to make final assignments (watch the blackboard for the announcement).

Kandhy Franklin needs some assistance the day of the event to help transport vendors from the Crest School, where we are asking them to park their cars, back to the park after they have unloaded their cars. IT IS TIME TO BE PROACTIVE!! At the last San Miguel Fire Board meeting, it was announced that Fire Protective Services, (NOT A PART OF San Miguel), will be focusing their efforts of citing CREST residents who have not done the weed abatement according the regulations of defensible space, Zone 1 & 2 abatement. In response to this, residents who attended the meeting, gathered together to create a web site to help residents with rules and regulations regarding fuel reduction, types of fire-retardant plants, links to resources, other

community fire safe councils, and Fire-Wise Communities. They also worked with San Miguel's Leonard Villarreal, ELM's Johnny Gonzales to create a series of flyers, which will be handed out to residents to remind them of the clearing needed to be done. Thanks to the Boy Scouts, Kiwanis, ELM, and church volunteers from Eastlake communities, the first wave of flyers have been handed out. **SEE PAGES 35-36 FOR SPECIFIC GUIDELINES FOR WEED ABATEMENT.**

Crest residents who serve on the benefit accounting committee met with Augie Guio to review the monies for East County Fire Protection District. With cuts in programs, staff, and the closing of station 15, this was a very important meeting. The group found that the funding for the ECFPD (East County Fire Protection District) was intact. An excellent presentation of line items for the disbursement was given by the Chief.



CREST CERT TEAM - During the first few hours and days after a disaster strikes, emergency services could be overwhelmed, leaving families, neighborhoods and businesses on their own for hours or days. After the devastating Cedar fire of October 2003, the City of San Diego sought new solutions to meet this vital need. A new community based program called Community Emergency Response Team (CERT) was

developed by the Fire-Rescue department. CERT San Diego helped citizens become a part of the solution in their own communities. The program took advantage of the outpouring of volunteers that offered to help in disasters such as the Cedar fire, earthquakes and 9/11.

San Diego Fire-Rescue personnel train and empower citizens in safe, effective neighborhood CERT teams. CERT San Diego instructors teach citizens to take life-saving action to help families, neighbors, businesses and communities get through the first few hours or days when emergency services are overwhelmed. To expand this model, Recently CERT training was held for Crest residents.

The CREST CERT TEAM NEEDS YOUR INPUT! Members recently attended the Red Cross Shelter class and Fire Training Scenarios with five agencies in Valley Center. The team would like to hear from you. First, here are the thoughts of your CREST CERT TEAM: We would like to stage a disaster practice involving the community in **September**. We would invite other CERT teams to be a part of the morning as well as the fire departments and Cal-Fire, OES, Red Cross, Ham Radio Operators, and SDG & E who is in the process of raising (fixing) our siren. We would use the CCA clubhouse as the incident center for communications and triage; South Lane Park would serve as a receiving area for large animals (stuffed animals.) CFSC has divided the community into 10 areas. Each area would have a block warden with a hand-held ham radio to inform the incident center where each of the emergencies are. Crest CERT team would be following the FEMA incident command plan. If you are interested in helping in some way, being a block warden or a "skywatcher", please email Kandhy at: kandhyfranklin@cox.net. A map of the areas will be inserted in the next newsletter as well as being sent in an email to the community.



ONE CALL NOW EMERGENCY RESPONSE SYSTEM - In the last call made to the community, 5% of the calls did not go through. The CFSC will go through the list of incomplete calls and verify each missed call. **PLEASE**, if you have changed numbers let us know. The Crest Emergency Service is free to you; it is paid for through

donations of the community. We are able to make 10,000 calls for \$700.00. At this time, we have 1,784 phone numbers on our call list. Remember, if you have caller id the number which will show on your display is the number to the Crest Clubhouse, 44-CREST! If there are new neighbors, have them contact Kandhy Franklin at 619-444-4996 to add their numbers and email. CFSC has email which will keep you informed of the Crest activities. It is also helpful with lost animals, people, and adoption opportunities. The Crest community also has a great web-master in Karin Weiss who is constantly updating our web site, www.thecrestsun.com. She has added a horse corner, lost and found, and tons more. Check it out.







The following are segments from the April 12 minutes regarding Crest. For a full copy of the minutes, go to www.crestplanning.org:

Announcements:

A scoping meeting for the proposed Singing Hills Estates project will be held at the Department of Planning and Land Use on 5 May at 4 pm. Pat Ulm announced that the scoping meeting for Singing Hills Estates on 5 May is for taking input from the public about what should be considered by DPLU in evaluating the project and determining requirements for compliance with the California Environmental Quality Act (CEQA) and County planning ordinances.

Committee Reports:

Item 5b. Private Project Proposal. TPM 21172, Davison 4-lot split with remainder parcel, Montana Serena and Tracey Lane, Crest. Chairman Riggs reminded the Planning Group that it recommended approval of TPM 21772 at its March meeting, and that subsequently the County provided its scoping letter for the project. Mr. Davison reported to the Group that the scoping issues raised by the County are being addressed: some of the lot boundary lines are being adjusted to accommodate driveways in compliance with fire safety and County standards; extended surveys for the Quino checkerspot butterfly are being conducted. The applicant does not expect that additional Planning Group review and action will be necessary as the project proceeds. Unfinished Business:

Item 8. New Business. Consideration of applicants for Seat 1, Crest. Chairman Wally Riggs reported that one application for nomination to Seat 1, Crest, was submitted, but that the public notice published to advertise the vacancy and opportunity to apply contained errors. Due to possible confusion that might have dissuaded potential applicants, he decided to continue the application process another month, and to readvertise the vacancy correctly. He then introduced Mary Kay Francis, a resident of Crest, who did apply; she and any other applicants will be considered for nomination by the Group at the May meeting

The following are segments from the May 10 minutes regarding Crest:

Item 5a. Private Project Proposal. TPM 21080 RPL2, Bongiovani/Montana Serena Project, 4-lot split, 1530 Montana Serena and Gibson Highland, Crest. Chairman Riggs introduced Mr. Bruce Tait, representative of the project applicant, to discuss and explain this replacement map application. Mr. Tait stated that Parcel 4 was larger; that the Lot 4 panhandle width was enlarged to 35'; that all of the easements are approved; and that secondary emergency access for the project has been obtained through Gibson Highlands. Phil Hertel moved that the Planning Group recommends approval of TPM 21080 RPL 2 as presented. The motion passed (11 yes; 1 no: Manning; 0 abstain).

Item 5c. Private Project Proposal. Notice of preparation, EIR for Singing Hills Estates Project GPA 09-009, SP04-005, R04-012, TM5380 RPL2. Chairman Riggs introduced this Notice of Preparation of an Environmental Impact Report, reminding everyone that the agenda item topic is limited to recommendations concerning the scope of the EIR that will be prepared for the Singing Hills Estates Project. He reported that the County DPLU conducted a scoping meeting (that Pat Ulm attended); that it developed a list of potential impacts to be studied in the EIR; and that the Planning Group has an opportunity to suggest impacts and issues it recommends for study in the EIR. Pat Ulm distributed copies to the Planning Group of a comprehensive list of potential issues and impacts of the project that, according to CEQA Guidelines, the EIR should study. Mr. Lee Vance, representative of the applicant, offered to answer questions about the project, and he emphasized that the County wants to identify all of the potential issues and impacts related to the project as early as possible in the EIR preparation process. Several residents from Crest expressed concerns that the EIR will not be complete unless the studies of the project's impacts to traffic conditions and road maintenance include certain specific roads in Crest in the analyses, in addition to the obvious direct access connections to the project. Kandy Franklin, of the Crest Fire Safe Council, requested that the EIR includes a study of fuel mitigation measures that will be required in the open spaces surrounding the project. A resident of Harbison Canyon expressed concern that project impacts will require installation of a traffic light control at the intersection of Sycuan Summit Drive and Dehesa Road. Others expressed concerns about the project impacts to the existing undeveloped rural landscape vistas, to the existing dark night sky, to the existing quiet natural soundscape. One person expressed concerns about the potential impacts due to the amount of grading associated with the project. Pat Ulm moved that the Planning Group adds the public's comments and suggestions to the list of issues and impacts she distributed to the Group, and that the Group recommends that the EIR for the Singing Hills Estates includes studies of all of these issues and impacts combined. The motion passed (12 yes; 0 no; 0 abstain).

Item 6a. Public Project Proposal. Park Lands Dedication Ordinance (PLDO) Priority List. Judy Bowen distributed to the Planning Group members copies of the draft 2009- 3 2010 Priority List Requests, which includes responses and suggestions from the

community concerning the different parks. Mary Manning suggested adding an Outdoor Weight Room to the list for Old Ironsides Park. Kandy Franklin discussed the Nancy Jane Park encroachment into the street easement, suggested installation of dog drinking devices on 2 of the 5 water spigots in South Lane Park, and reported that the prospective insurance companies are deliberating how the split rail fence at South Lane Park affects its insurability. Judy Bowen moved that the Planning Group sends the amended 2009-2010 Priority List Requests to the County for its consideration. The motion passed (12 yes; 0 no; 0 abstain).

Item 7. Unfinished Business. Consideration of applications for Seat No. 1, Crest. Chairman Riggs stated that since the sole applicant had to depart the meeting earlier and was no longer present, he was tabling this agenda item until the next meeting.

Excerpts from Correspondence received from the Department of Planning and Land Use regarding the Singing Hills Estate Project:

June 17, 2010 – "The Department has received your request for a due date extension from the REC Civil engineering & Consulting for submittal of information requested in the DPLU EIR dated December 15, 2009. After reviewing your request and the circumstances of your project, the Department hereby grants approval of a 180 day due date extension. Therefore, the information/documents requested in the DPLU EIR Scoping Letter dated December 15, 2009 are now due on December 6, 2010

... The DPLU records indicate that your project has been inactive since June 8, 2010. Based on this information, your project will be placed in Idle Status if the required information and/or documents are not received by June 8, 2011.

Editor's Note: Kay Faris was appointed to the Vacant Crest Seat #1 at the June meeting.

Internet Tips: Scareware, Fake Anti-Virus Messages

Ever received one of those pop up messages out of no where telling you that your computer is infected with a virus? Or an official-looking screen pops up warning you "There is a problem on your computer and immediate removal is required. To scan, click 'Yes'". If you're not sure if it's real or not, what do you do? There is a good chance this might be scareware. Google did a 13-month study and found there are 11,000 registered Web sites offering "free" antivirus software that are actually malicious (harmful). These sites account for about 15 percent of all Internet scams in the country. There is no shortage of information on how to avoid these scams.

What to Look For:

- Rogue anti-virus/spyware programs or scareware often generate more "alerts" than the software made by reputable companies.
- You may be bombarded with pop-ups, even when you're not online.
- The popups will try to convince you to buy RIGHT NOW!
- If you've been infected, your computer may dramatically slow down. Other signs of infection include: new desktop icons; new wallpaper, or having your default homepage redirected to another site.
- Although fake software may closely resemble the real thing such as windows or your antivirus messages; it's rarely an exact match. Look for suspicious discrepancies.

Here are some do's and don'ts if one of these messages appear:

Do not press the X to close the screen. This may install a program that can gather your personal and financial information. If there's any doubt, you can close your browser immediately by pressing ALT+F4 (Mac users: press Command/Apple+Q) This will prevent any scareware from loading. Or hit Ctrl + Alt _ Del to view a list of programs currently running. Delete the "rogue" from the list of running programs, and call your computer maker's phone or online tech support service to learn if you can safely use your computer.

Prevention tips and suggestions:

- You might find Firefox is a safer browser to use rather than Internet Explorer.
- Keep you computer updated with the anti-virus and anti-spyware software and use a good fire wall.
- Never open an email unless you are positive about the source.
- Do not click on any pop up that advertises anti-virus or anti-spyware software.
- Do not download freeware or shareware unless you know it's from a reputable source. <u>Download.com</u> and <u>VersionTracker</u> appear to be fairly reputable sources. Unfortunately, freeware and shareware programs often come bundled with spyware, adware or fake anti-virus programs.

Scareware can attack you in any combination of ways:

- Accessing your credit card: scareware will deceive you into paying money for fake antivirus software.
- Identity theft: scareware will secretly invade your computer and attempt to record your keystrokes and banking/personal information.
- Scareware will attempt to take remote control of your machine to serve as a spam-sending <u>zombie</u> robot.

Removing Scareware

First and foremost, avoid allowing a rogue program to connect to the Internet. Typically, an uninstaller is placed under the Add/Remove Programs option in Control Panel - but the uninstaller seldom works. If your existing antivirus can't remove the rogue scanner, use SmitFraudFix - a free tool that specializes in the removal of this specific type of malware. SmitFraudFix is a free antivirus download that removes the Zlob trojan downloader and the malware that Zlob installs. SmitFraudFix can be run under Windows XP or Windows 2000 and is available for both English and French installations. While SmitFraudFix is offered free, the developer does accept donations on his website. http://antivirus.about.com/od/freeantivirussoftware/fr/smitfraudfix.htm



COUNTY APPROVES NEW LAKESIDE FIRE STATION PLAN

June 1, 2010 - County plans to help build a \$14.5 million Lakeside Fire Station/Administration Center and passed a significant milestone recently when the Department of Planning and Land Use (DPLU) approved the center's Site Plan Review Permit, moving it closer to an expected summertime construction-start.

The new station is being built as part of the Upper San Diego River Improvement Redevelopment Project, to improve fire protection for Lakeside residents and jump-start the redevelopment project that was approved in 1989. Supervisor Dianne Jacob and the Board of Supervisors re-energized the redevelopment project in 2007 by voting to appoint a DPLU project manager and hire a redevelopment consultant to work with the community to create a new business plan that made building the new fire station its top priority.

"This is a significant step forward for Lakeside," said Supervisor Jacob, "not just to improve fire and emergency medical service, but also to help boost this redevelopment project, which has the potential to create and reinvest millions of dollars into Lakeside."

The redevelopment plan will provide \$11 million --- \$550,000 a year for 20 years --- to buy land and build the two-story, 22,000 square-foot station. Located on 4.8 acres at Lakeside Avenue and Channel Road, the new station will replace the Lakeside Fire Protection District's smaller, 44-year-old Station #2 in Eucalyptus Hills. Once built, the new station will allow the fire district to consolidate all its administrative services in the facility, and include space for training. The station's first floor will house a fire engine, brush rig and ambulance. The second floor will include a classroom and emergency operations center.

Lakeside officials hope to complete construction in 2011.

THE SDG&E-FUNDED FIRE CHOPPER:

June 7, 2010 -No one can argue against adding firefighting resources to our regional arsenal. However, San Diegans should be aware of the bad irony associated with this particular chopper. The Sunrise Powerlink creates a serious risk of catastrophic wildfire on par with the 2003 and 2007 wildfires. Every San Diegan should review the document which comes straight out of the Sunrise Powerlink's own environmental report. If SDGE really wants to fight fire, it should dump the Deathlink and get serious about local solar, not imported, power."

NEW COUNTY CURFEW AIMS TO KEEP KIDS SAFE.

Young people in the unincorporated areas of the region will need to be home by 10 p.m. following a unanimous decision of the San Diego County Board of Supervisors. Supervisor Dianne Jacob urged turning back the curfew from 11 p.m. to 10 p.m. to make the County consistent with other cities and keep young people safe.

The curfew will apply to all those under 18 loitering in public places without permission from a parent or guardian. It won't apply to minors at or heading home from sanctioned events.

Jacob joined forces with District Attorney Bonnie Dumanis and Sheriff Bill Gore to advocate for the earlier curfew. The three officials said the move will stop young people from seeking out jurisdictions with later curfews to stage parties. Jacob said the change will especially help crack down on gang-related activity in the Spring Valley area.

"I can tell you firsthand that Sherriff's deputies need this important tool to make communities safer," Jacob said, describing a scene she witnessed during a recent curfew sweep in Spring Valley. Jacob said deputies and probation officers lacked the authority to break up a large party outside an apartment complex at 10:30 p.m. The group included suspected gang members.

"Statistics reveal that the hour between 10 p.m. and 11 p.m. is prime crime time for kids. By enforcing the earlier curfew we can ensure that kids are exactly where their families believe them to be," Jacob said. "For kids that are in the wrong place, we're working with law enforcement, community groups and faith-based organizations to put them on a path to better behavior."

Local statistics suggest that the enforcement of an earlier curfew will lessen the number of crimes against juveniles and especially target violent crimes. More than 43 percent of curfew violations within the Sherriff's jurisdiction occur on Friday and Saturday night, according to the Sheriff's Department.

The cities of San Diego, El Cajon, La Mesa and Santee have 10 p.m. curfews. The County plans to contact cities with 11:00 p.m. curfews to request the earlier hour

<u>Cajon Valley Kids Serve:</u> Our education program with the Cajon Valley Union School District, 'Cajon Valley Kids Serve' (CVKS) brought over 2,600 students to the reserve this school year along with over 80 teachers... our most productive CVKS year so far. The program is currently supported by a grant to the district which will carry us through 2 more school years.

Other EDI Education Programs: Our program, under the direction of Education Coordinator, Vicky Bonnett, is highly respected county-wide. The non-profit agency, Wildcoast, and the US Fish and Wildlife Service have contracted with EDI to have Vicky and our great instructors implement environmental education programs. Their programs serve several hundred students in Chula Vista and Imperial Beach, allowing us to share our vision about science, native habitat and environmental stewardship throughout the county. Kudos to our staff for giving us such a great reputation, and working so well with these terrific partners. Sustainability: To sustain our work after the grant funds end, community contributions are needed in two forms: Volunteers: If you love the outdoors, recognize the value encouraging the next generation of environmental stewards, and have a few hours to spare each month you should consider becoming an EDI education docent. Critters in Crest

Crane Flies
By Stanley A. Shelton

Crane flies look like giant mosquitoes, but do not bite humans or animals like mosquitoes do. They are often called mosquito hawks, though they do not eat mosquitoes (dragon flies are the real mosquito hawks). They have also been mistaken for male mosquitoes, but are actually larger than male mosquitoes. Crane flies are not considered medically



important to humans. They are harmless, but can be a nuisance when they enter buildings or homes in large numbers, usually in spring.

At work one year, there were a lot of crane flies entering the building at the shipping and receiving area. Mike, who worked there, called me on the phone and asked me to tell him what all those insects were coming in the back bay door. He thought they were 'mosquito hawks'. I told him they were crane flies, but I couldn't tell him much more about them until I looked them up. That was several years ago. I had to research them anew for this article.

Adult crane flies are terrible fliers and easily caught. Their flight pattern is wobbly and awkward. Their legs are very long and very fragile and easily broken off. Their sole purpose as adults is to mate to create the next generation of larvae and crane flies.

Crane fly larvae are called leatherjackets. They mostly eat organic debris and forbs, but also eat the roots of grasses and sometimes other plants. Though rarely doing much damage to your grass, in large

numbers they can create sizable brown spots in lawns, and then need to be dealt with. You can tell if the brown spots in your lawn are caused by leatherjackets by digging in the area. The larvae can be found in the upper inch or two of a typical lawn.

There are about 14,000 species of crane flies, though little is known about the life cycle of the majority of them. Of all crane flies, family *Tipulidae*, the largest group of flies (75%), were found by Charles P. Alexander. (I should look him up.)



In England, crane flies are known as 'daddy long legs', a term used to describe two types of spiders here in the United States. Both are harmless, and one



isn't even a true spider. Here in Crest, the crane Photo by David Cappaert flies you may find in your house are harmless. Just a nuisance if they come in-in large numbers.

Homeowner's Guide To FUEL MODIFICATION

Reducing Combustible Vegetation Around Your Home

Many parts of the unincorporated areas of San Diego County share expansive, rural settings of native vegetation. These rural areas have natural fire cycles that place residents at risk.

Creating a **Defensible Space** around your home will help protect your home and provide a safety zone for fire fighters. Fuel **Modification** is a key component of creating a **Defensible Space** around your home. Proper Fuel **Modification** breaks up the continuous path of fuel that could carry wildfire to your home.


3 R's of Defensible Space:

REMOVE dead and dying grass, shrubs, and trees.

REDUCE the density of vegetation — prune, mow, and thin.

REPLACE hazardous vegetation with less flammable plants or irrigated landscape.

Do NOT disc or scrape soil with machinery—this is not a grading permit.



BOTTOM LINE: Fuel Modification increases the chance that structures will survive a wildfire.

Proper Fuel Modification Practices


Thin combustible vegetation by mowing, pruning, or cutting.

Chipping brush into mulch is okay — contact Fire Safe Council for more information.

The desired condition is a fire-safe, maintained landscape, not bare ground.

Do <u>not</u> remove streamside vegetation or dump litter in streambeds. Contact Fire Department or Wildlife Agencies before removing dead streamside vegetation.

If you have an open space easement on your property, consult its conditions or the County of San Diego before modifying vegetation.



Thin 10 ft. from roads & driveways.

Before thinning vegetation outside your property lines, contact the adjacent landowner (private and public) or the Fire Department.

Natural vegetation remains.

GOAL: Create a Defensible Space around structures.

Wildlife Agencies' Legal Notice to Landowners about Endangered Species

Landowners who have been notified by the California Department of Fish & Game or U.S. Fish & Wildlife Service that rare, threatened, or endangered species occur on their property in areas requiring fuel modification must notify both agencies in writing at least 10 days prior to removing vegetation. The agencies will have up to 10 days following such notification to (1) determine whether the proposed clearing complies with State and/or Federal endangered species requirements and (2) to suggest voluntary, alternative abatement measures if feasible and warranted. Failure of the agencies to respond within 10 days will allow the landowner to proceed with abatement activities without further delay. Failure by landowners to provide adequate notification as described above may render landowners liable under State and Federal law.





A Little About Homeowners Insurance

Confused regarding your options for obtaining insurance for your home? Are you finding it difficult to locate companies willing to cover areas that are considered "high risk?" Here are two websites that might help your search

The California Department of Insurance is

responsible for enforcing many of the insurance-related laws of the state. Their number one priority is to protect insurance consumers by regulating the industry's practices. The CA Dept of Insurance website www.insurance.ca.gov is full of information to assist you in your search. One valuable piece of information I found was a 2010 Homeowners Survey located at: www.insurance.ca.gov/0150seniors/0200beforebuy/Shop4ResIns.cfm This web page allows you to enter specific information about your desired coverage type (homeowners, condominium, mobile, earthquake ins. etc), the age of your house, your location (El Cajon) and amount of coverage desired. It provides a list of potential companies and their premiums and deductibles for the amount you requested. This is a great starting place for your insurance search.

The Insurance Information Network of California – (http://www.iinc.org) is a non-profit, non-lobbying organization dedicated to informing consumers and the media about the property/casualty business. IINC is the recognized leader in communications for California insurance consumers. There is great information on their website including the following checklist of things to consider and discuss with your agent when buying homeowners insurance:

- 1. Be sure to shop around. It'll take a few phone calls, but they could save you a good sum of money. Ask your friends, or call your state insurance department. Consumer guides, insurance agents and companies can I give you an idea of price ranges. The insurer you select should offer both a fair price and excellent service. Then, when you've narrowed the field to three insurers, get price quotes.
- 2. Raise your deductible. Deductibles are the amount of money you have to pay toward a loss before your insurance company starts to pay according to the terms of your policy. Deductibles on homeowner's policies typically start at \$250. By increasing your deductible to \$500, you could save up to 12 percent; \$1,000, up to 24 percent; \$2,500, up to 30 percent; and \$5,000, up to 37 percent, depending on your insurance company.
- **3. Buy your home and auto policies from the same insurer.** Some companies that sell homeowners, auto and liability coverage will take 5 to 15 percent off your premium if you buy two or more policies from them.
- **4. When you buy a home...** Consider how much insuring it will cost. Is your house close to a hydrant or fire station? The closer your house is to firefighters and their equipment, the lower your premium will be.
- **5.** Insure your house, not the land. The land under you house isn't at risk from theft, windstorm, fire and other perils covered in your homeowners policy. So don't include its value in deciding how much homeowners insurance to buy. If you do, you'll pay a higher premium than you should.

- **6. Beef up your home security.** You can usually get discounts of at least 5 percent for a smoke detector, burglar alarm, or dead-bolt locks.
- **7. Stop smoking** Smoking accounts for more than 23,000 residential fires a year. That's why some insurers offer to reduce premiums if all the residents in a house don't smoke.
- **8. Seek out discounts for seniors.** Retired people stay at home more and spot fires sooner than working people. Retired people have more time for maintaining their homes, too. If you're at least 55 years old and retired, you may qualify for a discount of up to 10 percent at some companies.
- **9.** See if you can get group coverage. Employers, alumni and business associations often work out an insurance package with an insurance company at very competitive rates.
- **10.** If you stay with an insurer... If you've kept your coverage with a company for several years, you may receive special consideration. Several insurers will reduce their premiums by 5 percent if you stay with them for three to five years and by 10 percent if you remain a policyholder for six years or more.
- 11. Compare the limits in your policy and the value of your possessions at least once a year. You want your policy to cover any major purchases or additions to your home. But you don't want to spend money for coverage you don't need.
- 12. Look for private insurance first. If you live in a highrisk area and have been buying your homeowners insurance through a government plan, you should check with an insurance agent or company representative. You may find that there are steps you can take that would allow you to buy insurance at a lower price in the private market.
